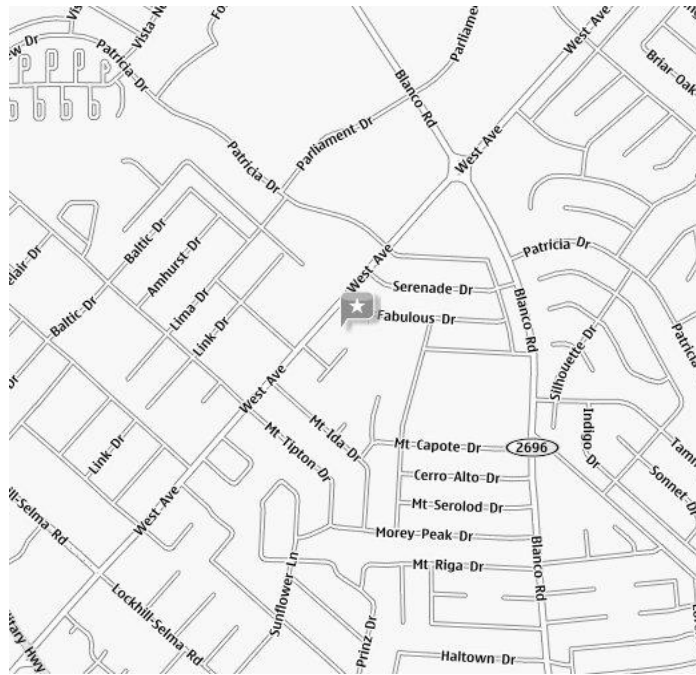
To enroll:

Note: Class start requires sufficient enrollment. Dates subject to change and funding availability.

Cost: For those attending voluntarily or without a court order from a Bexar County judge, the registration fee is \$75 and each of the eight classes cost \$35. **Those taking the course without a Bexar County judge’s order are not eligible for reduced pricing.**

To receive a reduced fee at registration, you must provide proof of income and evidence that a Bexar County judge has ordered attendance of this class (for example: signed order, judge’s notes, transcript of judge’s ruling)

Sliding scale, based on participant’s gross income when ordered by a Bexar County judge:

Individual Income	\$0-\$10K	\$10K-\$20K	\$20K-\$30K	\$30K-\$40K	\$40K or >
Fee for Initial Intake Session (one time fee)	\$0	\$15	\$30	\$50	\$65
Fee for Each Cooperative Parenting Group Session	\$0	\$10	\$15	\$25	\$35
